

Participation Contract



Terms & Conditions

- In this Contract, His Fuarçılık Hizmetleri Ltd. Şti. shall be referred to herein as the "Organizer", the real or legal persons participating in the forum shall be referred to as "Participants" and the Participatory Contract to the Forum shall be referred to as the "Contract".
- This Contract has been accepted and signed by the parties as a commercial contract. OMEGA Binder, 4810 Gmunden Austria and OMEGA GmbH 83410 Laufen Germany have been assigned as General Sales Agents and General Sales Representatives for WGBF by HIS Fuarçılık Hizmetleri Ltd. Şti. and acts as contracting partner on behalf of the "Organizer".
- The obligations of the Organizer are:
 - General cleaning of the exhibition area (stand cleaning belongs to the Participant),
 - Listing the name and logo of the exhibitor on the official website and mobile application of the event,
 - General decoration of the Exhibition area,
 - Promoting the Forum,
 - Taking security measures related to the Exhibition area (The Organizer is only responsible for taking measures related to the general security of the Exhibition area, and the insurance and all other responsibilities of the exhibited goods of the Participant and staff thereof belong to the Participant),
 - Providing the Participant an exhibition booth in the exhibition area (shown in attached plan), including the services mentioned in this contract
 - The Organizer has full authority in the exhibition area and has the right to give instructions from the beginning of the entrance through the end of the exit.
 - The Organizer will be available from 19 May 2021 08:00 to 23 May 2021 23:59 at the exhibition area.
- The obligations of the Participant are as follows:
 - Unless otherwise stated in the Contract, participant has to pay the full amount of the Forum participation fee in advance, up to one day before the starting date of the Forum
 - Having the decoration project approved by the Organizer and the Venue authorities due to the occupational safety laws (responsibility is entirely belongs to the Participant),
 - The Participant is always have to be present in the exhibition booth and could not close the booth until the closing date,
 - The Participant is liable to the law for the personnel to be employed and the goods and services to be exhibited. Participant is also liable for advertisement and advertising taxes,
 - The Participant may not lease or transfer the rights it will obtain with this contract to any other person or organization, even partially.
 - The responsibility of all kinds of damages to be caused to other Participants, visitors and third parties during loading and transportation of the exhibited goods, belongs to the Participant. It is forbidden to drill walls, wall panels, aluminum materials and similar stationary materials, to nail, to paint, to use adhesive material other than double-sided tape and to damage the fixed areas in the activity area. Otherwise, the Participant is obliged to pay any damage in cash immediately,
 - Participant has to comply with the technical and administrative specifications to be sent by the Organizer to the prior to the Exhibition such as advertising, noise, age limit, obscenity law, tobacco and alcohol legislation, construction conditions, catering and so on. The Participant agrees in advance to comply with the rules in this technical and administrative specification,
 - If the Participant does not comply with the payment dates specified in the Contract it accepts to pay a monthly interest rate of TL 5% and EUR 1%,
- Without prejudice to the other rights of the Organizer arising from the law, the Participant, who agrees to sign the Agreement to participate in the Forum, shall not withdraw from participating in the Forum except for the following articles a, b, and c and shall fulfill the obligations of the Contract.
 - In case the Participant decides not to participate in the Forum within a period more than 6 (six) months before the beginning of the exhibition, it has to pay 25% of the Contract fee.
 - In case the Participant decides not to participate in the Forum within a period of 6 (six) months or less than that, before the beginning of the exhibition, it has to pay 50% of the Contract fee.
 - In case the Participant decides not to participate in the Forum within a period of 3 (three) months or less than that, before the beginning of the exhibition, it has to pay 75% of the Contract fee.
 - The participant is not allowed to decide not participating in the Forum within a period of 2 (two) month or less than that, before the beginning of the Forum. Even if takes a decision unilaterally, it has to pay the whole amount of the Contract price (% 100). The participant is obliged to notify the cancellation statement in writing with a signed petition. The periods stated above in terms of Articles a, b, c and d shall be calculated according to the date on which the written notification reaches the Organizer. In this case, the usage right of the rented place belongs to the Organizer.
- In case the Forum cannot be fully regulated and / or cannot be arranged in the place specified in the contract and / or partially edited and / or postponed for reasons arising from the actions or decisions taken by the public authorities or for reasons caused by the owner and / or operator of the area in which the Forum is to be organized, or for forceful reasons or other justifiable reasons in the relevant legal regulations, the Organizer is free to notify the Participant and execute the Contract by declaring a new venue and Exhibition area (by setting the participant's new stand - number) and / or cancel the Forum completely by notifying the Participant (the notification made to the fax or e-mail addresses of the participant in the contract or the publication on the Organizer's web page applies). In case the organizer chooses to cancel the Forum from these optional rights; The fee paid shall be refunded to the Participant. In the event that the Organizer chooses any of the optional rights listed above, the Participant may not make any claim against the Organizer such as expenses, interest, compensation, indemnity etc.
- The Organizer shall have the right to terminate this Contract and not to include the Participant in the organization and Forum if he / she considers it necessary for the general safety of the Forum, even though the certificate of participation is issued or this Contract is signed. In such termination, the Participant cannot participate in the Forum in any way, cannot make any claims such as expenses, interest, loss, compensation etc. In that case, the Organizer shall refund the Participant if there is a charged fee.
- Contracts will be made in Euro currency. In the case of contracts made in other currencies, the conversion is made to the Euro, based on the Turkish Central Bank Currency Sales Rate of the day the payment is made. When the invoice issued, if there is a debt and receivable arises due to the exchange rate difference in the current account, this figure will be liquidated by arranging an invoice including VAT, and the parties have accepted, declared and undertaken that they will not claim any receivables and rights from each other.
- The music and video shows performed by the participant within the stands shall be made in a way not to disturb the environment. The Organizer reserves the right to cut off music and video shows if there is a complaint.
- The Participant agrees and accepts that the Organizer has no commitment for the commercial success of the Forum and that he / she participate with free will thereof without being under any pressure.
- The appearance of the stands should be perfect. Opened packages, packages and items that are not used for presentation purposes and items belonging to personnel should be kept in places where visitors cannot see. It is obligatory to have an authorized person at the exhibition area during the visiting hours. Participants cannot disassemble their own stands and take their products out before the end of the Forum, even if the duration is extended. It is forbidden to cover the products to be exhibited during the Forum visit hours. The covers used at night should not be seen by visitors and should be kept in an unseen place. The Organizer reserves the right to remove the covers on the products that are in violation of the safety regulations and will not be liable for any damages resulting from such damage. Any person employed by the Participants and staying in the exhibition must be properly dressed, be always gentle and behave appropriately.
- The Parties undertakes to ensure and maintain confidentiality of all oral and written information including, but not limited to, fax and e-mail correspondence between two companies. In this Contract, Trade Secret means all kinds of data, information, documents, and technical information whether technical or not, including but not limited to, doctor, patient, employee information, business information, plans, projects, technical designs, inventions, know-how, brands, patents, equipment, devices, documents, data and engineering and financial information (including, but not limited to, fax and e-mail correspondence between two companies). The Parties shall use all Trade Secrets solely for the success and purpose of the Contract and shall keep such information confidential under any other circumstances.
- For all disputes arising from the application of this Contract, Turkish laws shall prevail and Istanbul (Central) Court and Enforcement Directorates are authorized.
- This Contract consists of 2 pages, 14 articles and 1 attachment including special participation conditions and was signed by the parties making necessary negotiations on all contract articles without any pressure.
